The Ad-hoc Bid Evaluation Committee recommended that, the bid be split among the three bidders as follows; **JR Bridge Investment cc** for the supply and delivery of **five (5) VVIP portable ablation** and **six (6) portable cabin toilets** at a total amount of **N\$131,730.00**, **Devrim Investment**

cc to supply and deliver the remaining sixteen (16) portable cabin toilets at a total amount of N\$41,800.00 and Kweni-Pewa to supply and deliver the remaining five (5) VVIP portable ablution at a total amount of N\$198,331.10. The Grand total for the bid stands at N\$371,861.10. This splitting of bid was necessary, because the lowest evaluated responsive bidder called JR Bridge Investment Cc does not have all the items requested in this bid, the second evaluated responsive bidder is Devrim Investment cc at a total cost of N\$505,590.00 which is economically high, so after further considerations, the Bid Evaluation Committee decided to spilt, as indicated above.
