SECTION I: INVITATION FOR BIDS

1. Rights of Public Entity

The Zambezi Regional Council reserves the right:

- (a) to split the contract as per the lowest evaluated cost per item, or
- (b) to accept or reject any bid; and
- (c) to cancel the bidding process and reject all bids at any time prior to contract award.

2. Preparation of Bids

You are requested to quote for the items mentioned in Section III by completing, signing and returning:

- (a) the Bid Letter in Section II with its annex for *Bid Securing Declaration*,
- (b) the List of Goods and Price Schedule in Section III;
- (c) the Specifications and Compliance Sheet in Section V; and
- (d) any other attachment deemed appropriate.

You are advised to carefully read the complete Invitation for Bids document, including the Special Conditions of Contract in Section VII, before preparing your quotation. The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction.

3. Validity of Bids

The Quotation validity period shall be 14 days from the date of submission deadline.

4. Eligibility Criteria

To be eligible to participate in this Quotation exercise, you should:

- (a) Farmer must be a resident of Zambezi Region/ Katima Rural Constituency.
- (b) Farmer must provide proof of ownership i.e. livestock registration, stock card and eartags.
- (c) Farmer must provide proof of residence (letter from Traditional Authority);
- (d) Farmer should attach photos of the Cattle;
- (e) An assessment to check the overall health of the cattle will be carried out to ensure that the cattle are healthy before purchasing.
- (f) Attach a quotation

Additional Requirements:

1. Documents to be completed with black ink
2. No eraser fluid (tippex) to be used.
3. All pages to be initialled and signed where applicable.
4. All corrections to be initialled.
5. A certified ID copy of the owner

5. Delivery

Delivery shall be 30 days after acceptance/issue of Purchase Order. Deviation in delivery period shall not be accepted.

6. Sealing and Marking of Bids

Bids should be sealed in a single envelope, clearly marked with the Procurement Reference Number, addressed to the Secretariat, Procurement Committee, Zambezi Regional Council, Private Bagg 5002, Katima Mulilo, Namibia with the Bidder's name and contact information at the back of the envelope.

7. Submission of Bids

Quotations should be delivered/deposited in the Bid Box located at Zambezi Regional Council ground floor, not later than 03 March 2026, at 10H00 latest. Quotations by post or hand delivered should reach Zambezi Regional Council ground floor bid box, by the same date and time at latest. Late quotations will be rejected. Bids received by e-mail will not be considered.

8. Opening of Bids

Quotations will be opened by Zambezi Regional Council Procurement Management Unit, 2nd floor, on the 03rd March 2026. Time 10H00 latest.

Bidders or their representatives may attend the Bid Opening if they choose to do so.

9. Evaluation of Bids

Zambezi Regional Council shall have the right to request for clarification in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of price or ownership cost, subject to Margins of preference where Applicable, to determine the lowest evaluated quotation.

11. Technical Compliance

Bidders shall submit along with their quotation's documents, photos, and any other literature to substantiate compliance with the required specifications and to qualify deviations if any with respect to Zambezi Regional Council requirements.

The specifications, Performance Requirements and Compliance Sheet details the minimum requirements of the goods/items to be supplied. The specifications have to be met but no credit will be given for exceeding the specifications.

12. Prices and Currency of Bids

Bids shall be fixed in Namibian Dollars.

13. Award of Contract

The Bidder having submitted the lowest evaluated responsive quotation and qualified to supply the goods items and related services shall be selected for award of contract. Award of contract shall be by issue of a Purchase Order/Letter of Acceptance in accordance with terms and conditions contained in Section VI: Contract and General Conditions of Contract.

14. Margin of Preference

15. Notification of Award and Debriefing

Zambezi Regional Council shall after award of contract promptly inform all unsuccessful bidders in writing of the name and address of the successful bidders and the contract

amount and post a notice of award within seven (7) days. Furthermore, Zambezi Regional Council shall attend to all requests for debriefing made in writing within seven (7) days of the unsuccessful bidders being informed of the award.
